11. We should be disciplined and selfless in performing our duties.
12. As per the protocol, we must and you should keep contact mandal leaders approach to district presidents. All district leaders approach to zonal presidents. All zonal presidents approach to state presidents and regarding our duties. If you can misuse of NHRPF rules or if you can do illegal works there is no responsibility of NHRPF.
13. If any in-disciplinary act is filed against you or if you cross over the committee's instructions the committee will take a serious action against you.
14. We also have ladies in our whatsapp group so don't post any messages which may cause them inconvenience. Don't make any personal call or post a message to any of their personal mobile numbers.
